Also, 36 Lake Dr site visit on August 11th Member Fletcher moved to accept the minutes and Member Wheeler seconded, the vote was: Member Pitney-Yes, Member Wheeler-Yes, Member Sprague, Member Socha and Member Raftery Abstain, the vote was 3 Yes and 3 Abstain.
