Patrick said that Mr. Finnerty had some modifications he wanted to make and would like to continue the meeting in two weeks.

Chuck made a motion to continue. Patrick seconded. Aye Patrick, Aye Chuck, Aye Jamie.

Change of Manager Hearing

Next was the hearing for review and approval for Green-Land Market, LLC DBA Elm Street Market application for Change of Manager.

Patrick made a motion that they approve the manager. Chuck seconded; all were in favor.

Minutes

Take action on minutes for August 11th, August 25th, September 8th and September 22nd, 2022. Patrick continued taking action as he had not read them yet.

Adoption of Chapter 90 § 17C

Establishment of 25-miles-per-hour speed limit in thickly settled or business district.

Mike said that this was discussed a year ago and this allows the Select Board to set a speed limit of 25 mph by local approval. Chuck made a motion that they accept it. Jamie seconded; all were in favor.

Regional Shared Mental Health Co-Responder Program for the Communities of Lee, Lenox, and Stockbridge

Patrick said that they are planning on hiring a LICSW and splitting the cost with Lee and Lenox. Stockbridge's share will be \$42,8312 for the first year with proposal that a grant will fund future years. Mike recommended that this is taken from ARPA money. The three Town chiefs will be doing the hiring through Tri-Town. Chuck made a motion that they adopt it. Jamie seconded; all were in favor.

Jamie made a motion that they use part of their ARPA monies that are available for funding of this program, our Stockbridge part. Chuck seconded; all were in favor.

Sign warrant for the state election

Patrick announced that they are signing the warrant.

Discussion Trick or Treat

Mike said that they are traditional set for 5 PM – 7 PM on Halloween night; October 31st. Chuck made a motion to set the trick or treat night. Jamie seconded; all were in favor.

Public Comment

Wendy Pearson, representing the Library and Chamber of Commerce, said that they are collaborating on the annual pumpkin walk which will take place on Friday, October 28th from 6 to 7:30 PM. The parade starts at the Red Lion and ends at the front lawn of the Library where cider and donuts donated by Stockbridge Coffee and Tea will be served along with a craft and story time. There is also a decorated walk way through the library gardens.
