Re: Indian Burial Ground

Dear Town of Stockbridge Selectboard:

Koonamunthe'ma.

I am writing to regarding the Town's consideration of returning the "Indian Burial Ground" parcel of land in Stockbridge to the Tribe (shown on map attached).

Our program has the official and sacred responsibility for our Nation to preserve our ancestral burial grounds and other cultural sites such as these in our Mohican homelands. I am offering additional information for your reference: Attached is the text of the 1809 land agreement by five Stockbridge-Munsee sachems wherein they state that this remaining area of our land in Stockbridge had not been relinquished and which they asked resident Dr. Oliver Partridge to assist in preventing the "soil from being removed that the bones our Ancestors may there lie undisturbed." This agreement was made under pressure of a planned road project and as a last resort to advocate for the grave site protection, while our Nation was being forced to remove further west.

If the concept is supported at the Town Selectboard meeting, Historic Preservation requests that the Town send an official letter to the Stockbridge-Munsee Tribal Council informing them of the Town's interest to return the Stockbridge Indian Burial Ground back to the Tribe, for their consideration as our Tribal Government. 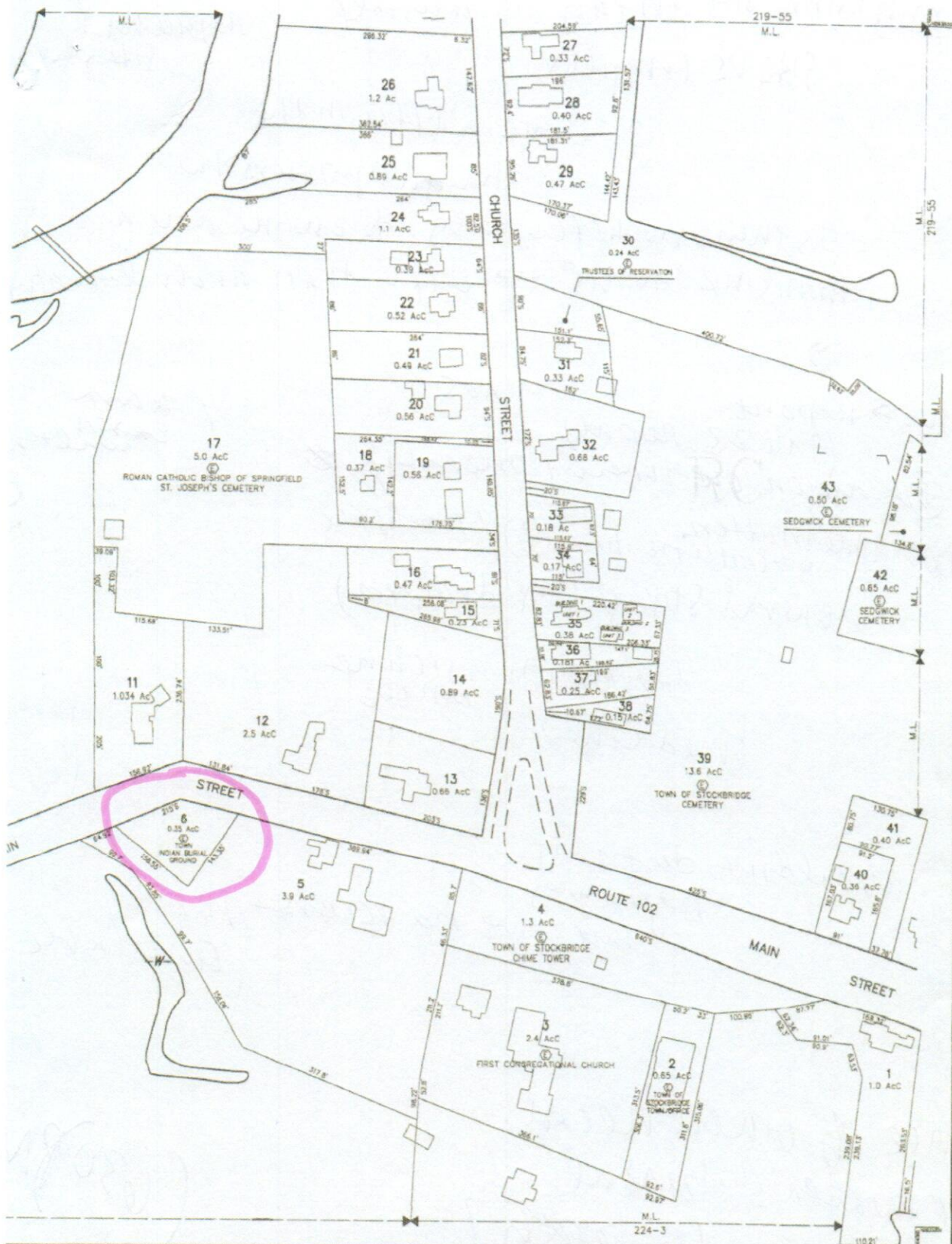

INSTRUMENT

Know all men by these presents that we, **Joseph Shauqueatheat, Hendrick Aupaumut, Solomon Q. Hendrick, Joseph Quinney, and John Metoxen, Sachems and Counsellors of the Muhhuonnut tribe of Indians who formerly were proprietors of the Town of Stockbridge** in the County of Berkshire and Commonwealth of Massachusetts and some years since removed therefrom and who now reside in New Stockbridge in the State of New York. In consideration of ten dollars in certain services rendered our tribe by and the trust and confidence we place in our friend Oliver Partridge of Stockbridge aforesaid we do for ourselves and for our whole tribe hereafter relinquish to him our right to a certain piece of land lying in Stockbridge there called the **Indian Burying Ground lying west of the Town Square there so called and is fully described on their Town records reference thereto to be had which ground never has before by any of us or our forefathers been sold or any ways relinquished;** we hereby acknowledge the receipt of the services aforesaid and do by these presents quit claim, release and transfer to him the said Oliver Partridge our right and title to the aforesaid premises for the following uses and purposes, viz: That he may fence the same that he **may in every way prevent the soil from being removed that the bones of our Ancestors may there lie undisturbed** that he may plant trees round and over the same which trees are ever to be considered as the property of said Oliver his heirs or assigns and improve the same in any way except tilling or breaking up the sod or turf; we do hereby empower him as fully in his own right to sue for and recover as if held the premises by deed of warrantee for any strip waste or damage committed in any ways on the said premises; and we do hereby fully empower him to assign and transfer to others in trust and for the purposes and uses aforesaid the same right, and title to the said premises.

IN WITNESS WHEREOF we have hereunto set our hands and seals the 8th day of February in the year of the Lord one thousand eight hundred and nine.
